THEREFORE ALL THE DISTRICT AGRICULTURAL OFFICERS IN THE STATE ARE REQUESTED TO ISSUE STOP SALES ORDERS FOR (30) DAYS ON THE ABOVE MISBRANDED BATCH OF THE PRODUCT AND GIVE WIDE PUBLICITY IN THE LOCAL NEWSPAPERS DULY ADVISING THE FARMING COMMUNITY NOT TO PURCHASE / USE THE MISBRANDED BATCH PESTICIDE AND INITIATE ACTION AS PER THE PROVISIONS OF INSECTICIDES ACT 1968.

FURTHER, THEY ARE ALSO REQUESTED TO SUBMIT THE DETAILS OF DETENTION OF STOCKS TO THIS OFFICE WITHIN THREE DAYS BY FAX WITHOUT FAIL. ANY DEVIATION IN THE MATTER MAY BE VIEWED SERIOUSLY AND RESPONSIBILITY WILL BE FIXED ON ALL THE CONCERNED AS DEEMED FIT.
